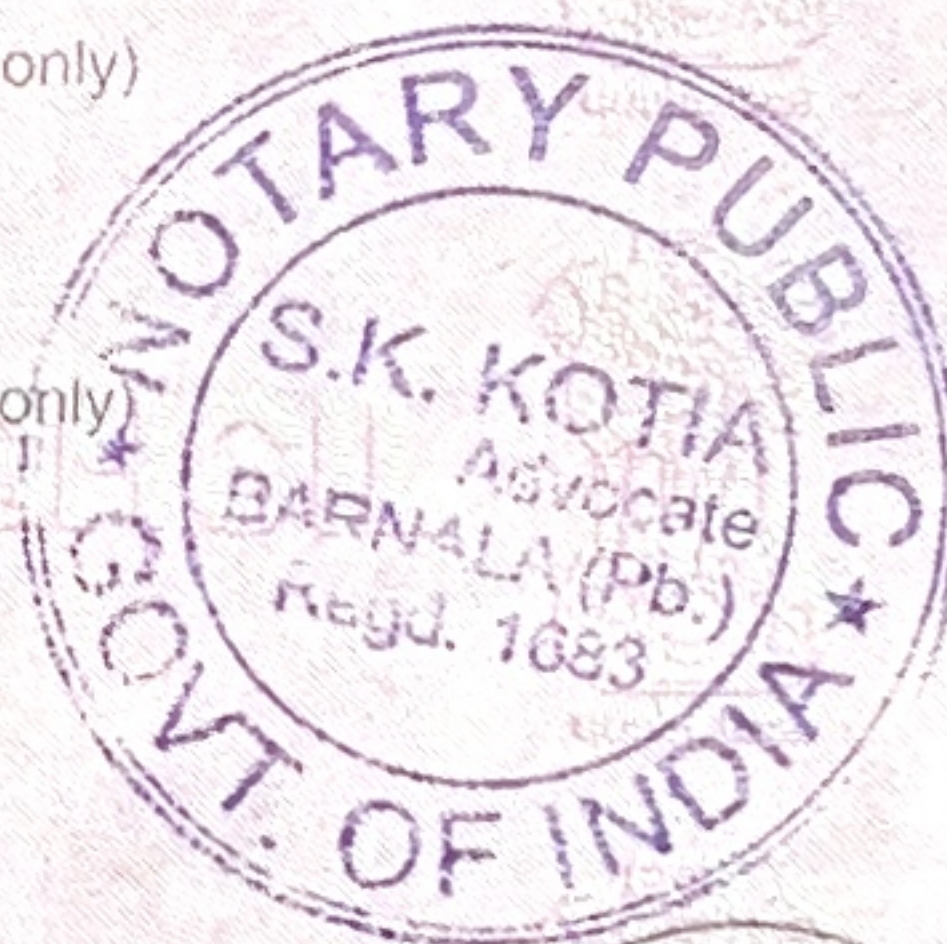

INDEMNITY BOND

The Indemnity Bond made at Aryabhata College Barnala, this 09 day of September 2025 between Shree Krishna Educational & Charitable Society, Barnala, society registered under Act, 1860 and now governed under society Registration ACT XXI of 1860 with its Headquarter located at ICIT Campus, Patel Nagar, Street No.1 Barnala, Hereinafter referred to as the Association (which expression shall, unless it be repugnant to the context or meaning there of deemed to include its successors, assigns and persons for the time being having control over its assets and affairs); of the one part and the University Grants Commission a body corporate established and constituted under the University Grants Commission Act, 1956 hereinafter referred as the 'Commission' (which expression shall unless it to be repugnant to the context or meaning thereof include its Successors and assigns of the other part.

Whereas the Association as the owner is conducting Various under Graduate, Post Graduate and Post Graduate Diploma in Computer Application at Cheema- Jodhpur (Barnala) a college known as Aryabhata College, Barnala herein after referred to as the said college.

And whereas the said College is affiliated to Punjabi University Patiala constitutes under Punjab Act No. 35 of 1961. Act, hereinafter referred to as the said University.

And whereas the Commission in carrying out its objects and functions has sanctioned grants out of its funds to the said college.

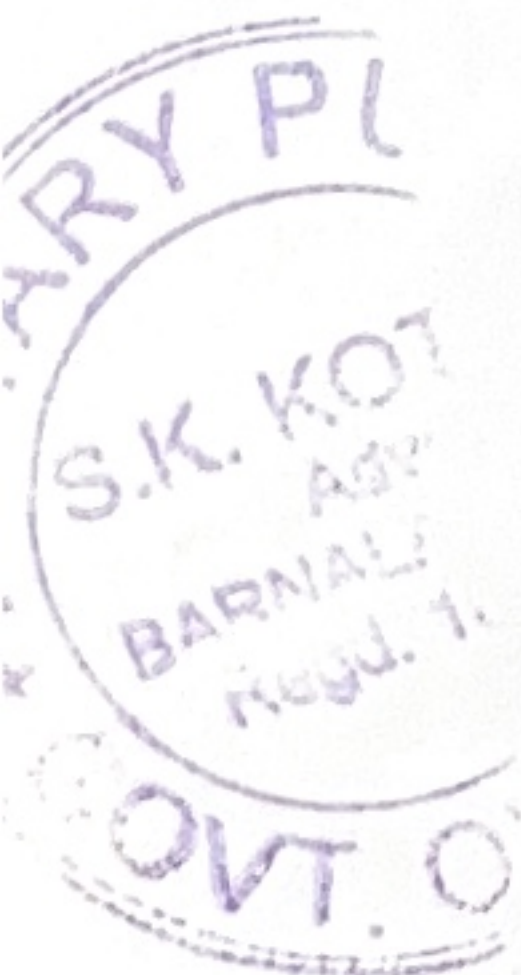
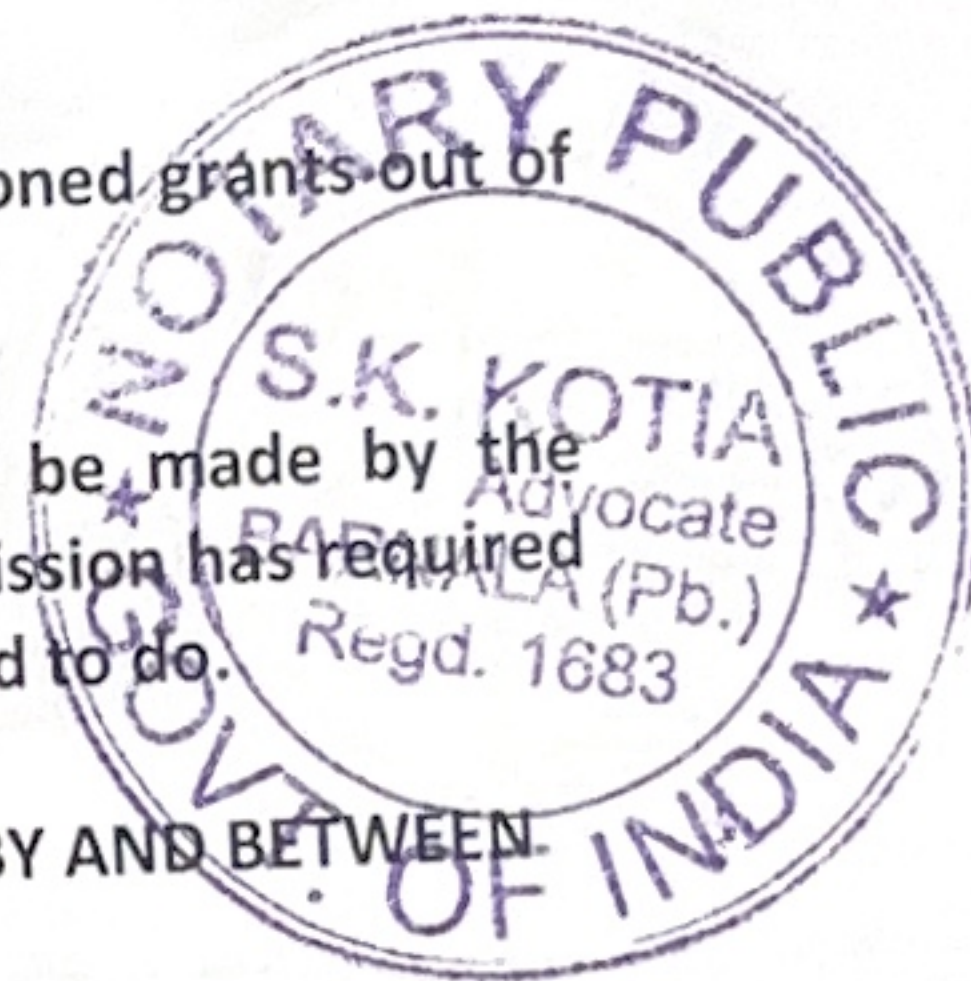
And Whereas in order to regulate and control the use of grant that may be made by the commission to the said College as terms and conditions of the grant, the commission has required the Association to execute this indemnity bond which the Association has agreed to do.

NOW THIS INDENTURE WITNESSED AND IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS:

1. The association here by guarantees and covenants with the commission that every amount of Grant that will be given by the commission to the said college shall when received by the said college Solely be used for the benefit and purposes of the said college in accordance with the terms and conditions of the grants and not for any other purpose or any other institution run by the said association and in the event of any part of the said grant being found to have been used by the associations for any purpose other than the purpose of the said college or for any other institution run by the association, the same shall be refunded by the association without demur to the commission on demand. The decision of the commission as to the misuse of the amount of Grant and as to the quantum of the amount payable by the association shall be final and binding on the association.
2. The association further covenant with the commission that the association shall furnish to the commission the balance sheet of the association every year along with the annual audited accounts of the said college managed or run by the said association. The said balance sheet and the annual accounts will be sent to the commission within 2 weeks from the passing thereof by the association and in any event before the closing of the financial year of the association.
3. The Association hereby agrees to indemnify and keep indemnified the Commission against any loss that the commission may suffer on account of improper or misuse of the grant or
